You may be eligible to receive an 8% rebate on your electricity bill effective January 1, 2017 under the Ontario Rebate for Electricity Consumers Act, 2016. If your account meets any of the eligibility criteria below, please check off all boxes that apply, and sign and date the form. Once completed, please return to PUC Services.

If you qualify for the rebate, we will retroactively credit your account (as applicable) to consumption effective January 1, 2017 or to a maximum of two years from the date you provided us with the completed self-declaration form, if submitted after January 1, 2019.

To be eligible to receive the 8% rebate on your electricity bill, you must qualify under at least ONE of the following criteria:

You carry on a business that is a farming business...
Your account relates to one of the following:
(i) a dwelling,
(ii) a property, within the meaning of the Condominium Act, 1998,
(iii) a residential complex...
(iv) a property that includes one or more housing units...
